

NOK Group's New Automotive Seals Plant in India Scheduled to Begin Operations in January 2025

NOK Corporation (Headquarters: Shibadaimon, Minato-ku, Tokyo; Representative Director, Group Chief Executive Officer: Masao Tsuru; hereinafter referred to as "NOK") has established the Morinda Plant in collaboration with its Group company, Freudenberg NOK Pvt., Ltd. (Headquarters: Chennai, Tamil Nadu, India; Chairman: Kerstin Borrs). Located in Morinda, Punjab, India, this new plant will produce automotive seal products. The inauguration ceremony for the plant, which will serve as a production hub for northern India, was held on Tuesday, October 15. The Morinda Plant will incorporate equipment relocated from the Basma Plant in the same state and commence operations in January 2025.

The Morinda Plant will manufacture engine seals, valve stem seals, dust covers, O-rings, and other automotive-related products for both local Indian manufacturers and Japanese, European, and American automotive manufacturers with operations in India. By introducing automated equipment, the plant is expected to increase production by approximately 10% (annually) compared to FY2024 levels. The plant's rooftop will also be equipped with a 1.5MW solar power system and the latest rainwater harvesting system, establishing an environmentally friendly production setup.
